## WAUSA PUBLIC SCHOOLS ACTIVITIES PROTOCOL Policy as of August 21, 2020

**INDOOR ACTIVITIES:** To include but not limited to Volleyball, Basketball, School Concerts, School Plays and Graduation.

**Attendance:** Wausa Public Schools will follow attendance limitations based on the NCDHD recommendations.

Attendance will be limited to 75% capacity.

Visiting Pep Bands and Cheerleaders will not be allowed at this time.

Wausa Student Section will consist of current school students only(Grades 5-12). College students will not be allowed to sit in the designated Student Section.

Children are required to sit with their parents at all times unless sitting with the Student Section.

Post game congregations will not be allowed. Parents/Fans will be asked to leave immediately after the game/event.

**Masks:** Masks will be required upon entrance into all indoor activities and are to be worn as much as possible.

Children 6 years and under will not be required to wear a mask.

**Social Distancing:** Social Distancing Protocol of 6 foot is recommended for all family groups while in the bleachers. We ask that you make an effort to maintain social distancing in the lobby area although we realize due to the size of this area it will be difficult. For this reason masking in this area is critical.

**Concessions:** Concessions will be available but may be limited. Concessions workers will be required to wear PPE.

Protective screens will be set up in concession windows.

Concessions must be consumed outside of our facility or in the bleacher area. Eating in the lobby area will not be allowed.

Masks may be removed in the bleacher area to consume concessions.

**OUTDOOR ACTIVITIES:** To include but not limited to Football, Cross Country, Golf, Track

**Attendance:** Wausa Public Schools will follow attendance limitations based on the NCDHD recommendations.

Attendance will be limited to 100% capacity.

Visiting Pep Bands will be allowed at this time.

Wausa Student Section will consist of current school students only(Grades 5-12). College students will not be allowed to sit in the designated Student Section.

Children are required to sit with their parents at all times unless sitting with the Student Section.

Post game congregations will not be allowed. Parents/Fans will be asked to leave immediately after the game/event.

**Masks:** Masks will not be required for entrance at outdoor activities at this time. Masks are recommended in areas where social distancing can not be met, for example in the Restrooms or Concession area.

**Social Distancing:** Social Distancing Protocol of 6 foot is recommended for all family groups while in the bleachers. We ask that you make an effort to maintain social distancing in areas of concern such as the restrooms, concession lines, ticket lines if you are not in your car.

**Concessions:** Concessions will be available but may be limited. Concessions workers will be required to wear PPE. Screens will be set up in concession windows.

### **Additional Precautions**

Ticket Takers will be required to wear proper PPE.

Visiting Teams will be subject to Temperature Checks upon arrival.

All visiting teams using WPS Facilities will be required to wear masks upon entrance to the facility.

Water Jugs and Cups will be provided in Volleyball and Basketball.

Scoring Table personnel will be required to wear masks.
